

ORDINANCE NO. O-03-18

**AN ORDINANCE CANCELLING THE ELECTION OF CITY COUNCIL MEMBER
IN PRECINCT #3 SCHEDULED FOR MAY 5, 2018**

WHEREAS, an Order of Election passed on January 22, 2018 called the Regular Election of Council members for Precincts 3, 4 and 5 for the City of Crockett, Texas; and,


WHEREAS, at the deadline to file application for a place on the ballot, February 16, 2018, only one candidate had filed to run for City Council member – Precinct #3, that being Ernest Jackson; and,

WHEREAS, as prescribed in Section 2.052(a) of the Texas Election Code, the City Secretary has certified that:

- 1) The candidate whose name is to appear on the ballot is unopposed;
- 2) No candidate's name is to be placed on a list of write-in candidates for the above described offices under applicable law;
- 3) No proposition will appear on the ballot

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Crockett, Texas that based on information received and in accordance with Section 2.053, the City Council hereby authorizes the cancellation of election of City Council member – Precinct #3 called May 5, 2018 and hereby declares the unopposed candidate elected to office and shall be issued certificate of election following the time the election will be canvassed.

ORDINANCE NO. 0-04B-18

AN ORDINANCE CANCELLING THE ELECTION OF CITY COUNCIL MEMBER IN PRECINCT NO. 4 SCHEDULED FOR MAY 5, 2018.

WHEREAS, an Order of Election passed on January 22, 2018 called the Regular Election of Council Members for Precincts 3, 4 and 5 for the City of Crockett, Texas; and

WHEREAS, the Secretary of State of Texas has determined that two of the three candidates for the office of City Council Member in Precinct No. 4, through no fault of their own, are ineligible to serve as Council Members in Precinct No. 4; and

WHEREAS, those two candidates, Rita Rodriguez and Roy Simon, Jr., have voluntarily withdrawn their candidacy for office; and

WHEREAS, as a result of the withdrawals, only one eligible candidate has filed to run for City Council member, Precinct No. 4, that being Marquita Beasley; and

WHEREAS, as prescribed in Section 2.052(a) of the Texas Election Code, the City Secretary has certified that:

1. The candidate whose name is to appear on the ballot is unopposed;
2. No candidate's name is to be placed on a list of write-in candidates for the above described offices under applicable law;
3. No proposition will appear on the ballot.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Crockett, Texas that based on information received and in accordance with Section 2.053, the City Council hereby authorizes the cancellation of election of City Council member, Precinct No. 4 called May 5, 2018 and hereby declares the unopposed candidate elected to office and shall be issued certificate of election following the time the election will be canvassed.


